Werland just wanting to get idea what the Explorer is worth maybe \$5,000.00 or \$6,000.00 to use as trade in. Werland to find out how much it is worth. Discussion what to do with the Expedition. One of the vehicles is used for the Backpack program. Chief Werland took pictures at Bill Pascal's East 10th Avenue address showing mess at that residence. He talked to Mr. Bellville at the East Avenue L property regarding the holes in the side of the house. The holes are not all the way thru the wall into the inside. Mr. Bellville explained his wife had been sick before passing away and was short on money at this time because of doctor bills.
