LEWISTOWN CITY COUNCIL MEETING DATE February 23, 2016 at 6:00

MINUTES OF THE COMMITTEE MEETING:

MEMBERS PRESENT: Alderman Kelley, Weese, Barclay, and Burget, also Attorney Nathan Collins, Mayor John King and Cindy Goddard City Clerk. The Committee meeting was scheduled to discuss the Zoning for potential Hog Confinement. Also present Cindy Arnett, and Andrea Klinedinst, with the Canton Daily Ledger.

Cindy Arnett asked to pass a resolution that the city has no intention to let the hog confinement come in. City needs a blue print of project so the city can handle the water usage. Resolution needs to state that if it exceeds the capacity and we can shut water off. Estimated that 584 head of hogs are to be there.

Mrs. Arnett stated that the council must pass an ordinance or resolution stating that Lewistown has no intention of letting Bear Creek 4 or any other Animal confinement tap onto the water system without the appropriate information allowing the city to determine the volume the facility will use. They must fill out an application for water tap before receiving a final blueprint for the project so an independent study can evaluate the water supply situation. The document must also state that this procedure must be completed BEFORE each expansion. This protects the city.

The city wants to know exactly how much water they will use per minute.

This protects the people of our community and value of the houses. Chicago Weekly is following this story (project). National groups Farmers Union and SRA, Prairie Rivers also are supporting Mrs. Arnett.

The city can reject the request if we know it will use too much water and compromise our water system with the final blueprints.

All plans for the Bear Creek 4 are pretty sketchy at this time. Per Reba these are not Fulton County residence, they are from Hancock County. There are 11 other large confinements at this time over the state.

This Hog confinement may be to close to the walking track, has to be at least 50 people per week using the track, she is getting signatures of people using the track.
