- 4. Vote to Approve 3 ½ inch Dodge bearing for waste water plant for \$1.369.00. Alderman Barclay made a motion to approve purchasing a 3 ½ inch Dodge bearing for waste water plant for \$1,369.00, second by Weese, roll call vote, motion carried all ayes
- 5. Alderman Ford had person contact her regarding the side walk behind the County Market, on west side of Jefferson that was tore up during the building of the store and now the parking of semis. It was a recently new sidewalk. Should store be responsible to repair it? Alicia to talk to Kevin at store to see what will happen with it.

- 6. Mayor King said the city does not take two party checks. \$55,000.00 to \$60,000.00 a month is paid in water bills. Only about a loss of \$400.00 last year in water bills.
- 7. Per Mayor King hog farm in done deal. Wells were drilled they said because city not fast enough to accommodate them. Bear Creek did not furnish all information and tests (flow test, 4 inch line) the city needed to run water to them.
