The Lewistown City Council met in regular session in the council chambers. City Clerk, Cindy Goddard called the meeting to order at 6:30 p.m. with the Pledge of Allegiance.

- 3. Vote to pay for portion of Handicap ramp and sidewalk for Veterans Office County pay for half, we pay for half, total sum of \$3,700.00, includes remove and replace curb, sidewalk according to ADA requirements by Grimalkin Construction, Inc. Alicia Campbell said the city is responsible for sidewalk. Alderman Ford made a motion to pay half of Handicap ram and sidewalk for Veterans Office the sum of \$1,850.00, second by Burget, roll call vote, Spotloe yes, Burget yes, Barclay voted no, Weese yes, Kelley yes and Ford yes, motion carried.

- 2. Adopt Ordinance for Elected Officials Salaries Table at this time.
- 3. Place Appropriation Ordinance on file Place on file.
- 4. Approve Water Tap for Bear Creek Genetics, LLC Table at this time. EPA requires 4 inch main, not 1 inch water tap as on the application.
- 5. Vote to keep CD at Ipava State Bank for 16 months @1% Barclay made a motion to keep CD at Ipava State Bank for 16 months @1%, Kelley second it, roll call vote, all ayes.

- 6. Vote to give a donation for fireworks. Mayor King said the money could come out of the Tourism Fund. Alderman Burget made a motion to donate \$2,000.00 out of the Tourism Fund for fireworks, Kelley second it, roll call vote, motion carried with all ayes.
- 7. Vote to sell 1979 Jetter can sell to another municipality. Alderman Ford, made a motion to sell 1979 Jetter, Barclay seconded it, so moved, all ayes.
- 8. Discuss time change for council meetings. Alderman Barclay made a motion to keep same time 6:30 p.m., second by Weese. All ayes.
- 9. Adopt Electronic Participation Ordinance Alderman Ford made a motion, to adopt Electronic Participation Ordinance, second by Burget, all ayes.
- 10. Vote to proceed on new well at Well Field one well collapsed recently, have to drill new one. Around \$100,000 for new well, try to roll this amount into the EPA loan. Another option get bond or use CD at Ipava State Bank. Go ahead and try to roll this amount into the EPA loan. All ayes, motion carried.
- 11. Closed Session-Personnel Barclay made a motion to go into closed session, second by Weese. Closed door at 7:08 p.m.

Alderman Barclay made a motion to resume open session, Weese second it, all ayes.
