- 3. Michelle Mutton TIF Application Michelle Mutten wants to open a small coffee, bakery, café behind courthouse. She is going to rent lower part of Masonic Lodge Building, will host meetings, showers, birthday parties and such. This building needs new bathroom; she will add a kitchen area, needs new lighting and plumbing. City Council has never given this large sum of money to someone that does not own the building before. Mayor added that it won't be done though. Will take information and have committee meeting BEFORE next meeting. Alderman Burget said maybe need to meet with lodge members. She has spoken to bank and financial advisor already. Would also like a liquor license to have wine and poker machines at business. At this point no more liquor licenses available. She wants to be open Monday thru Friday only, then open on weekends for maybe birthday parties. Will have to speak to TIF attorney to see how this

- 4. Discuss Car Repair Shops Alderman Barclay thinks rest of repair shops need cleaned up. See if Chief can talk to them, already talked to the people at Bainter's old lot. Per Mayor each business can have a certain amount of cars and the cars can be their so many days maybe 10. Barclay just wants them cleaned up some, so they look better, that's all.
- 5. Discuss 2017 Sidewalk projects. Alderman Burget spoke to Dennis Monn regarding this. Mayor stated that his project was included in budget every year when the city has the money usually \$15,000.00. On Jewel street, a man in a wheel chair tipped over because to steep and bad sidewalk. This needs taken care of to avoid a law suit. Burget wants a list of sidewalks that can be done next summer.
- 6. Discuss property located at 502 West Washington Chief Werland, presented pictures, Darby Beaird owns property, back taxes are not paid \$36,000.00. The property will probably go back to a trustee and then will sell to an interested party. Not in budget for use to tear it down. Mayor to talk to lawyer about this property to see if the city can do anything.

- 7. Discuss Sidewalk at Railroad Crossing on Main- City was going to extend the sidewalk but the Railroad said no because they were going to do something with it, but it has been 2 years and nothing done yet. Table at this time.
- 8. Appoint New City Administrator Mayor appointed Amanda Woodruff as new city administrator taking over from Alicia Campbell. Alderman Spotloe made motion to appoint Amanda Woodruff as new City Administrator, seconded by Burget, roll call vote, motion carried all ayes.
