OLD BUSINESS:

- a. Halbert Tiff application Alderman want to know who the Decker Construction Company is for labor, there is no phone number or address, need more information on them. Alderman Ford said no at this time for labor estimate, and ves for material. Table at this time.
- b. Pratt Tiff Application The attorney is against the same business purchasing their own stuff for TIFF grant. Tara Ward was asked how much she was expecting to get. She mentioned all donations and things the Pratt Business has done over the years, and stated that this is a major project for them. She would like half in grant and half in TIFF. Mayor King brought to their attention that there is only a certain amount generated each year. Tara Ward wanted to know if 1% loan is limited, yes limited to keep things fair among all businesses per Mayor King. Burget ask how long her family has had businesses in town, for around 50 years she stated. Burget thinks they should go 50% on each. Need to look at full amount in bank and see how much left in TIFF funds. Table till next meeting.
- c. Discuss and vote on New Doors Quotes for City Hall with safety push door lock for Pinnacle door, \$6,976.00 now, compare the three amounts. Baer Glass \$8,468.48, J & M Construction \$8,732.83. Alderman Spotloe believes should go with local person J & M Construction. Table at this time for everyone to review amounts again.
- d. Approve Little Food Pantry to be placed at Visitors Center Mayor King admitted he made a mistake when he already gave permission to put it up the Food Pantry Box on side of Visitors Center. The City is not liable for any food that may be bad or any consequences of it. Alderman Ford has problem with the religious symbols on the sides of the Box; she requested they be taken off because it is on a government building. The only food pantry in town is only open a few hours a week. Motion made by Ford, second by Burget, if religious sign comes off. Alderman Spotloe feels like the symbols should stay on. Alderman Spotloe motion to allow the Little Food Pantry Box be left on the side of the Visitors Center with the religious symbols on it, second by Weese, roll call vote, alderman Ford no, Kelley yes, Weese yes, Burget yes and Spotloe yes. Motion carried.

- a. Eaker Annexation and Sewer Tap (Linda Lane) Chad and Katie Eaker have to annex in to the city. Alderman Spotloe made a motion to allow the 4" Sewer Tap to Chad and Katie Eaker at 13265 North Linda Lane with proper signage, seconded by Kelley, roll call vote, motion carried all ayes.
- b. Approve Resolution to Modify Police Department Policy Manual Alderman Kelley wants to know about warning shots, it is according to situation per Chief Werland. Alderman Ford made a motion to approve the Resolution to Modify the Department Policy Manual of the Lewistown Police Department regarding "USE OF FORCE", seconded by Spotloe, roll call vote, motion carried all ayes.
- c. DCEO Sandy Disaster Recovery Grant for Well Field Project City should receive \$600,000 by end of week to reimburse EPA loan for Well Field Project.
- d. Approve Revised Change Order #5 for Well Field Project Alderman Spotloe made a motion to approve Revised Change Order #5 Well Field Project, seconded by Burget, roll call vote, motion carried all ayes.
- e. Discuss Casey's Liquor License change from Class D-1 to Class D. Alderman Spotloe agreed that no new licenses should be issued at this time. Most aldermen were present at the Liquor Commission meeting that took place at 6:00 p.m. Alderman Ford made motion to DENY the granting of the change from Class D-1 to Class D license for Casey's North and South, Spotloe seconded, roll call vote, motion carried all ayes
- f. Discuss County Market wanting to sell beer for consumption on the premises. Most Aldermen were present at the Liquor Commission meeting that took place at 6:00 p.m. Alderman Ford made a motion NOT to give permission to County Market to sell beer for consumption on the premises, seconded by Spotloe, roll call vote, motion carried all ayes.
