ORDINANCE LEVYING AND ASSESSING TAXES FOR CORPORATE PURPOSES OF THE CITY OF /ISTOWN, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2020 ENDING APRIL 30, 2021.

SECTION 1: That the total amount of budget for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to the sum of \$3,003,388

SECTION 2: That the sum of \$153,242 being part of the total budget heretofore legally made which are to be collected from the tax levy of the current fiscal year of the City of Lewistown for all corporate purposes of said City of Lewistown be, and the same is hereby levied upon all of the taxable property in the City of Lewistown subject to taxation for the current year for the following specified purposes:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEWISTOWN, FULTON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 5: That in the event that a court of competent jurisdiction should hereafter determine that one or more of the provisions of this Ordinance are invalid or unconstitutional, the remainder of this Ordinance, and each and every other clause and provision hereof, shall be and remain in full force and effect as though the invalid or unconstitutional provision had never been a part of this Ordinance.

SECTION 6: This Ordinance shall be in full force and effect immediately upon its passage by the City Council and approved by the Mayor thereof.
