- 2. Discuss/Act Upon 16 month CD in Ipava State Bank –Right now 16 month at 3 1/5%, Alderperson Miller suggested 8 month at 5.1%, Spotloe said Prairie State Bank is 7 month at 5.2%, Clark suggested stay at Ipava Bank. Motion by Alderperson Levingston to move it to Prairie State Bank at 5.2% for 7 months, second by Alderperson Miller, roll call vote motion carried all ayes.

#### **NEW BUSINESS:**

1. Discuss/Act Upon New Casey's Water & Sewer Tap – Alderperson Levingston asked if anyone remembered that the City did not charge County Market for their water and sewer

tap when they built the new store. Discussion most felt if they don't charge then they should not charge anyone. Motion by Alderperson Miller to approve the Water and Sewer Tap for the new Casey's along with the normal charges, second by Spotloe, motion carried all ayes.
