The City Council met in the council chambers for the appropriation budget meeting. This budget runs from May 1, 2021 to April 30, 2022 for FY 22. Beka Schultz with CliftonLarsonAllen said the budget looks fairly good compared to last year. A surplus in most funds. A trend statewide that gaming revenue is down significantly, and we will not be able to recover what we lost. Also, other revenue that will be down is police and waste water, Chief Werland would like a sergeant position added. According to Mayor Littlefield historically the Chief and Public Works receive the same pay. Employees to receive a \$1.00 raise included in budget. Minimum wage went up \$11.00 in January it will go up again. Mayor Littlefield commented that all did a great job getting this put together, and worked hard putting it together. The Public Works Director Evinn Palmer has broken down more line items and has worked hard on this. Alderperson Clark asked about the Cure money and that is already added in as revenue in the General Fund if it has to be used in a specific way. Yes, and that is already included in the revenue in General Fund being paid in wo deposits one in FY 22 and the other in FY23. Present was Mayor Elmer Littlefield Jr., Alderperson Miller, Alderperson Clark, Beka Schultz, with CLA, Treasurer Debbie Brown (on Zoom), and City Clerk Cindy Goddard. Adjourned at 6:10 p.m.

Jodi Grigsby, first of all want to thank everyone, on application guide lines she talked to attorney ahead of time before getting application, and on her agreement, it says no labor. The instructions say that labor is paid, she knows that you can't pay yourself but husband is a contractor. On application it is covered. When read ordinance it says different. She said that the Attorney said that the Lewistown guidelines are different than others. Jodi said that the attorney said he was directed by an elected official to change. You just cannot pay yourself, she said subcontractors are paid. Her agreement reads different. Mayor said that alderman had previously said that you cannot pay yourself. Mayor explained you cannot pay yourself. Doug said that Jodi is saying her agreement is different. She wants the alderman to know the application and the agreement say something different. Cindy Goddard said they have always paid the labor and it will be paid. Mayor asked why did she sign agreement before reading. Jodi said she received an email from the Attorney that said the elected officials said no labor. She feels hers is different. She is nurse so she does not understand all the legal stuff. This needs to be put on agenda so we know ahead of time to check things out explained the Mayor. Mayor Littlefield said nothing was changed after voted on. She feels that HER contract was prepared different. Cindy Goddard said the other agreement with Preston Bainter says the same, material only. **Public Works Report**: Found a large leak out in country by Dickson Mounds Road, it was an 8-inch cast iron pipe that broke and that was filling into a pond. Losing 70 to 100,000 gallons a day It was estimated by the unaccounted-for water that it started in February, they got it fixed. The City got a bid for MFT for seal coat, that will be discussed later. Fire hydrant excel sheet in the packets presented to the alderman along with sample of map. Evinn Palmer explained the excel sheet regarding the 160 fire hydrants. Shows if painted, pipe size, date flushed and date fire hydrant made and if need replaced. Evinn told them he is making excel sheets showing water loss and water usage to present to the alderman, the water loss is getting better. Trying to get to exact number. Alderperson Lafary asked what percentage for water loss

now, Evinn said in the mid-teens to twenty. Alderperson Miller and Clark agreed glad he is on top of it. Also, the big water meters can be bought now, so will get them ordered so they are all in one shipment.

#### **NEW BUSINESS:**

- 1. Discuss/Approve Gordon, Stockman & Waugh FY21 audit engagement letter: Mayor Littlefield explained that these are the ones we have had the last couple years. Alderperson Miller made a motion to approve the engagement letter with Gordon, Stockman & Waugh for FY21 audit, second by Alderperson Clark roll call vote, motion carried all ayes.
- 2. Discuss/Approve Annual Appropriation Ordinance: This is the Appropriation Ordinance for FY22 budget. Appropriation meeting was at 6:00 p.m. Public Works and Chief of Police historically made the same hourly pay. Minimum wage went up \$1.75 and again it will go up in January another \$1.00. Because of this the \$1.00 raise has been added to this budget. All involved was Evinn Palmer, Cindy Goddard, Chief Werland and Mayor Littlefield helping Beka Schultz prepare the budget. Beka said the budget looks better this year than last. Cures Grant added to the revenue in General Fund. Deficient in recycling and tourism, video gaming is down because of the Covid 19 which affects the tourism. The police salaries will eat up most of the \$132,000.00 cure money received in the 1<sup>st</sup> half in FY21 and 2<sup>nd</sup> half next year. Rules change constantly how the Cure money can be spent. Motion by Alderperson Clark to approve the annual Appropriation Ordinance, second by Alderperson Pascal, roll call vote motion carried all ayes.
- 3. Discuss/Approve MFT Seal Coat Bids: Only one bid by IRC, Inc. from Jacksonville, Illinois. The bid was \$75,494.38 and engineer's Estimate was \$75,862.25. 5<sup>th</sup> year in row dividing town up to do tar and chip according to Mayor Littlefield. Planning on seal coating the West side this year. Alderperson Miller asked what kind of oil, not sure. The oil we use now does not bleed thru; Mayor Littlefield checked into that previously. Motion by Alderperson Clark to approve the MFT Seal Coad bid from IRC, Inc., second by Alderperson Spotloe, roll call vote, motion carried all ayes.
