Discuss/Act Upon awarding the Fairground Site Pump Station Improvement Project to Laverdiere Construction Inc in the amount of \$1,196,101.00 using the \$600,000.00 USEPA grant and \$227,537.65 remaining ARPA funds, and \$368,563.35 of local funds. The building we are using has 2 pumps one is a diesel engine pump as a back up. The new building is a pre engineered pump station. Thursday December 5 was the bid

opening with three sealed bids received on from Kemper Construction, Leander Construction and Laverdiere Construction. The plan is to take down the small water tower and small building, right now the power is falling off the building, all electrical will be underground now. Three bids were opened Laverdiere Construction Inc. was the lowest bid of \$1,196,101.00. Using the \$600,000.00 USEPA grant, ARPA funds of \$227, 537.65, short amount of \$368,563.35 planning on taking it out of our local funds in the budget. This construction will not start till next fiscal year. Need new transformer from Ameren, may have a small cost there. Details explained by Keith Plavec, he has reached out to the USEPA to confirm the grant, everything alright. The award document will be sent out tomorrow, should get all signed documents back by December 20, 2025. Motion by Alderperson Miller, to approve Laverdiere Construction Inc. in the amount of \$1,196,101.00 for the Fairground Site Pump Station Improvement Project, along with the \$600,000.00 USEPA Grant, ARPA Funds in the amount of \$227,537.65 and local funds in the amount of \$368,563.35, second by Alderperson Long, roll call vote motion carried all ayes.

5. Discuss/Act Upon a Contract between the City of Lewistown and Maurer Stutz, and an Agreement for Reporting between the City of Lewistown and Fulton County for the Fulton County Community Revitalization Grant - Grant money from coal mines being closed down. Total \$50,000.00 all grant money. Eleven communities will divide this money a 5 year plan for everyone to utilize the money. City of Lewistown the largest of the 11 communities. No out of pocket costs, we pay, then the County will reimburse, has to be used to develop roadways. Motion by Alderperson Miller to approve the contract between City of Lewistown and Maurer Stutz on the agreement for the Fulton County Community Revitalization Grant, second by Alderperson Long, roll call vote motion carried all ayes.
