- B. Vote on Façade agreement for WashZone (carwash) looking for \$3063.49. Alderman Spotloe made a motion to approve Façade Agreement in the amount of \$3,063.49 for the WashZone Carwash, second by Burget, roll call vote, motion carried all ayes.
- C. Vote on TIF Agreement for WashZone Application for the grant, \$21,630.00. (\$86,000 new unit) Alderman Burget made a motion to approve the TIF Agreement in the amount of \$11,630.00, with a 1% loan of \$10,000.00 for WashZone, second by Spotloe, roll call vote, motion carried with all ayes.
- D. Vote on Façade Agreement for WashZone (Laundromat) looking for \$3768.32 Alderman Ford made a motion to approve the Façade Agreement in the amount of \$3,768.32 for WashZone Laundromat, second by Spotloe, roll call vote, motion carried all ayes.
- E. Approve engineer estimate of cost for sidewalk on west side of square Table at this time. Total cost needs to be lower to approve this.
- F. Approve Ordinance approving Redevelopment Agreement with Lewistown Historical Society Alderman Ford made a motion to approve a redevelopment agreement with Lewistown Society for Historic Preservation in the amount of \$10,000.00 annually reimbursed total of \$40,000.00 in accordance with all approved plans, second by Barclay, roll call vote, motion carried all ayes.

- B. Vote to approve Façade Agreement with Scott Lucas (Subway) \$19,470.00 parking lot and alley. \$5,000.00 façade grant. Alderman Ford made a motion to approve Façade Agreement grant of \$5,000.00 with Scott Lucas (Subway), second by Barclay, roll call vote, motion carried all ayes.
- C. Vote to approve TIF Agreement with Scott Lucas (Subway) Mr. Lucas is spending \$19,470.00 on parking lot this includes parking by the Lewistown Visitors Center. Alderman Barclay made a motion to give back 75% of the tax

- increase of \$225.00 for 11 years to Scott Lucas (Subway), second by Burget, roll call vote, motion carried all ayes
- D. Vote to award bid for well field improvements contingent upon approval of IEPA loan. Alderman Barclay made a motion to award bid for well field improvements contingent upon approval of IEPA loan seconded by Burget, roll call vote, motion carried all ayes.
